

Notes for Table 1:

- 1. Nominal CCT as defined by ANSI C78.377-2011.
- 2. Minimum Rg value for 90/90 CRI products is 50. Minimum Rg value for 93/95 CRI products is 85. Bridgelux maintains a ±3 tolerance on all CRI and Rg values.
- 3. Products tested under pulsed condition (10ms pulse width) at nominal drive current where T_i (junction temperature) T_c (case temperature) 25°C.
- 4. Typical performance values are provided as a reference only and are not a guarantee of performance.
- 5. Bridgelux maintains a ±7% tolerance on flux measurements.
- 6. Minimum flux values at the nominal drive current are guaranteed by 100% test.
- 7. Typical stabilized DC performance values are provided as reference only and are not a guarantee of performance.
- 8. Typical performance is estimated based on operation under DC (direct current) with LED array mounted onto a heat sink with thermal interface material and the case temperature maintained at 85°C. Based on Bridgelux test setup, values may vary depending on the thermal design of the luminaire and/or the exposed environment to which the product is subjected.

European Product Registry for Energy Labeling

The European Product Registry for Energy Labeling (EPREL) is defined in the EU Regulation 2017/1369 to provide information about a product's energy efficiency to consumers. Together with Energy Labeling Regulation ELR (EU) 2019/2015, which was amended by regulation (EU) 2021/340 for energy labelling of light sources, manufacturers are required to declare an energy class based on key technical specifications from each of their product and register it in an open data base managed by EPREL. It is now a legal requirement for a vendor of light sources to upload information about their products into the EPREL database before placing these products on the market in the EU.

Table 2 provides a list of part numbers that are in compliance with EPREL regulations and are currently listed in the EPREL database.

Notes for Table 3:

- 1. Parts are tested in pulsed conditions, $T_c = 25^{\circ}$ C. Pulse width is 10ms.
- 2. Voltage minimum and maximum are provided for reference only and are not a guarantee of performance.
- 3. Bridgelux maintains a tester tolerance of \pm 0.10V on forward voltage measurements.
- 4. Typical coefficient of forward voltage tolerance is ± 0.1mV for nominal current.
- 5. Thermal resistance value was calculated using total electrical input power; optical power was not subtracted from input power. The thermal interface material used during testing is not included in the thermal resistance value.
- 6. V_r min hot and max cold values are provided as reference only and are not guaranteed by test. These values are provided to aid in driver design and selection over the operating range of the product.
- 7. This product has been designed and manufactured per IEC 62031:2018. This product has passed dielectric withstand voltage testing at 500 V. The working voltage designated for the insulation is 45V d.c. The maximum allowable voltage across the array must be determined in the end product application.

- 4. Bridgelux recommends a maximum duty cycle of 10% and pulse width of 20ms when operating LED arrays at the maximum peak pulsed current specified. Maximum peak pulsed currents indicate values where the LED array can be driven without catastrophic failures.
- 5. Light emitting diodes are not designed to be driven in reverse voltage and will not produce light under this condition. Maximum rating provided for reference only.

Figure 1: CCT vs. Forward Current 2700K-1800K




Figure 2: CCT vs. Forward Current 3000K-1800K




Figure 3: Color Shift vs. Forward Current 2700K - 1800K




Figure 4: Color Shift vs. Forward Current 3000K - 1800K





Figure 5: Forward Voltage vs. Forward Current, T_=25°C

Figure 6: Relative LOP vs. Drive Current, T_c=25°C




Figure 7: Relative Flux vs. Case Temperature





Figure 8: Derating Curve



Typical Radiation Pattern


Figure 9: Typical Spatial Radiation Pattern



Figure 11: Typical Color Spectrum



- 4. Unless otherwise specified, tolerances are \pm 0.10mm.
- 5. The optical center of the LED array is nominally defined by the mechanical center of the array. The light emitting surface (LES) is centered on the mechanical center of the array to a tolerance of \pm 0.2 mm
- 6. Bridgelux maintains a flatness of 0.1 mm across the mounting surface of the array. Refer to Application Notes for product handling, mounting and heat sink recommendations.





Notes for Figure 14:

- 1. Each tray holds 30 Vesta Series Dim-To-Warm 13mm arrays.
- 2. Eight trays are sealed in an anti-static bag. One such bag is placed in a box and shipped. Depending on quantities ordered, a bigger shipping box, containing more boxes will be used to ship products.
- 3. Each bag and box is to be labeled as shown above.
- 4. Dimensions for each tray are 200 (W) x 12(H) x 300 (L) mm. Dimensions for the anti-static bag are 440 (W) x 350mm (L) x 0.1 mm (T) mm and that of a shipping box are 350 x 245 x 67 mm.

In addition to the product identification markings, Bridgelux arrays also contain markings for internal Bridgelux manufacturing use only. Eye safety classification for the use of Bridgelux Vesta Series is in accordance with IEC/TR62778: Application of IEC 62471 for the assessment of blue light hazard to light sources and luminaires. Vesta Series Dim-To-Warm arrays are classified as Risk Group 1 when operated at or below the maximum drive current. Please use appropriate precautions. It is important that employees working with LEDs are trained to use them safely.

CAUTION: RISK OF BURN

Do not touch the Vesta Series LED array during operation. Allow the array to cool for a sufficient period of time before handling. The Vesta Series LED array may reach elevated temperatures such that could burn skin when touched.

CAUTION

CONTACT WITH LIGHT EMITTING SURFACE (LES)

Avoid any contact with the LES and resistors. Do not touch the LES or resistors of the LED array or apply stress to the LES (yellow phosphor resin area). Contact may cause damage to the LED array.

Optics and reflectors must not be mounted in contact with the LES (yellow phosphor resin area). Optical devices may be mounted on the top surface of the Vesta Series LED array. Use the mechanical features of the LED array housing and edges to locate and secure optical devices as needed.
