







European Product Registry for Energy Labeling

The European Product Registry for Energy Labeling (EPREL) is defined in the EU Regulation 2017/1369 to provide information about a product's energy efficiency to consumers. Together with Energy Labeling Regulation ELR (EU) 2019/2015, which was amended by regulation (EU) 2021/340 for energy labelling of light sources, manufacturers are required to declare an energy class based on key technical specifications from each of their product and register it in an open data base managed by EPREL. It is now a legal requirement for a vendor of light sources to upload information about their products into the EPREL database before placing these products on the market in the EU.

Table 2 provides a list of part numbers that are in compliance with EPREL regulations and are currently listed in the EPREL database.

For example, if 200mA is applied to the 1800K/2700K channel, no current may be applied to the 4000K/5000K/6500K channel of the array. If 150mA is applied to the 1800K/2700K channel, then a maximum of 50mA can be applied to the 4000K/5000K/6500K channel.
- 5. Bridgelux recommends a maximum duty cycle of 10% and pulse width of 20ms when operating LED arrays at the maximum peak pulsed current specified. Maximum peak pulsed currents indicate values where the LED array can be driven without catastrophic failures.

Figure 1: Forward Voltage vs. Forward Current, T_=25°C




Figure 2: Relative Flux vs. Drive Current, T_=25°C




Figure 3: Relative Voltage vs. Case Temperature




Figure 4: Relative Light Output vs. Case Temperature





Figure 5: Relative Light Output vs. Case Temperature

Figure 6: CCT vs. Relative Warm White Current




Figure 7: CCT vs. Relative Warm White Current





Figure 8: CCT vs. Relative Current, Tc=85C

Figure 9: Relative Flux vs. Relative Current




Figure 10: Relative Flux vs. Relative Current




Figure 11: CCT Tuning Range, Tc=85




Figure 12: CCT Tuning Range, Tc=85






Figure 13: CCT Tuning Range, Tc=85



Typical Radiation Pattern


Figure 14: Typical Spatial Radiation Pattern




Figure 16: 2700K - 6500K with 90 CRI


Figure 17: 2700K - 5000K with 90 CRI

Figure 18: 1800K - 4000K with 90 CRI



Notes for Figure 19:

- 1. Connectors are labeled "+" to denote positive polarity and "-" to denote negative polarity of the warmer white and cooler white channels.
- 2. Poke-In connectors accept solid and stranded wires with AWG wire sizes 20 24.
- 3. Recommended wire strip length is 7.0mm +/-0.5mm.
- 4. Wires may be released by pushing into the wire release hole on the poke in connector. Bridgelux recommends the use of BJB tool 46.141.U801.89.
- 5. Mounting holes (2X) are for M3 screws.
- 6. Bridgelux recommends two tapped holes for mounting screws with 19.0 ± 0.10mm center-to-center spacing.
- 7. Screws with flat shoulders (pan, dome, button, round, truss, mushroom) provide optimal torque control. Do not use flat, countersink, or raised head screws.
- 8. The maximum mounting screw torque value is 0.3 N-m (2.7 lbf-in).
- 9. Drawings are not to scale.
- 10. Drawing dimensions are in millimeters.
- 11. Unless otherwise specified, tolerances are \pm 0.10mm.

Figure 20: Graph of Bins in xy Color Space, Tc=85C








- 4. The dimensions of the small shipping box are $350 \times 245 \times 67$ mm.

It is important that employees working with LEDs are trained to use them safely.

CAUTION: RISK OF BURN

Do not touch the Vesta Series LED array during operation. Allow the array to cool for a sufficient period of time before handling. The Vesta Series LED array may reach elevated temperatures such that could burn skin when touched.

CAUTION

CONTACT WITH LIGHT EMITTING SURFACE (LES)

Avoid any contact with the LES. Do not touch the LES of the LED array or apply stress to the LES (yellow phosphor resin area). Contact may cause damage to the LED array.

Optics and reflectors must not be mounted in contact with the LES (yellow phosphor resin area). Optical devices may be mounted on the top surface of the Vesta Series LED array. Use the mechanical features of the LED array housing, edges and/or mounting holes to locate and secure optical devices as needed.
